3. (S) Enemy Activity: There was one significant engagement; 1/4 Cav and 2/18 Inf engaged the 271 Reg't in a major battle lasting approx seven hours vic XU 725020.

- a. Ground Activity:
  - (1) BING LONG

(a) Initial contact came at 300930H when B/1/4 Cav received heavy mortar fire along the length of the column vic XU 725020. At 0945H, B/1/4 Cav began receiving intense AW and SA fire from vic XU 723020 and became heavily engaged as VC attempted to split the column. C/1/4 Cav and C/2/18 Inf moved forward to assist B Troop and also became heavily engaged. The VC employed quad .50 cal MG, single .50 cal MG, and recoilless rifles in addition to other AW and SA fire and had elements dug in and concealed on both sides of Hwy 13. Extensive air and artillery support was employed on the VC - both in the area of contact and on routes of withdrawal. US, ARVN, and CIDG units placed in blocking positions around the battle area received sporadic SA fire. US Casualties: 10 KIA and 66 WIA. VC losses: 300 VC KIA (EC), 300 VC KIA (est), eight VCC (WIA), 40 weapons (including one 7.62 MG on wheels and two 57 recoilless rifles), and one aid-bag containing syringes and several vials of drugs and medicine. (See para. 3. h. (3) (b) and (c)).

- (2) PHUOC LONG

(a) 292345H, 2/28 Inf patrol encountered an estimated ton VC vic YU 192041. The patrol fired on VC; VC fled east without returning fire, casualties unknown.

- (3) BINH DUONG

(a) 292055H, 1/26 Inf received six rds of AW fire vic XT877176. No US casualties.

(b) 292210H, 1/16 Inf received two rds of NL-79 or rifle grenade fire vic XT 752372 resulting in one US WIA.

(c) 300403H, 1/16 Inf destroyed five ox carts and killed one VC (EC) vic XT 702452.

(d) 301710H, 1/Engr sustained no casualties or damage from a command detonated mine set off between two vehicles vic XT 931080.

(a) 301500H, 2/28 Inf destroyed 20 well camouflaged bunkers with overhead cover, four houses with trenches and bunkers underneath, and a small amount of rice vic YU 199046.

- (a) 300915H, 1/16 Inf detained one VCS vic XT 711417.

VCS was turned over to BEM CAT authorities.

(b) 300925H, 1/26 Inf searched village vic XT 855135 into which three men were seen running earlier and found one pistol belt and two US grenades.

(c) 300415H, 1/16 Inf destroyed five CBU bomblets and one A/P mine vic XT 734374.

(d) 30 June, 1/26 Inf detained three VCS operating vic XT 85514, VCS turned over to ARVN.

(b) Reference para 3a (1) (a): Eight VC wounded in the battle were captured. Preliminary interrogations indicate the following: One VCC was a platoon leader and three were squad leaders. One squad leader DUONG VAN LAI, is from IVN, all captives are from 271st Reg't.

The entire 271 Reg't moved east to Hwy 13 during the night of 29-30 June with the intent of ambushing an American convoy. Some of the captives were told the ambush would take place 30 June and one squad leader knew there would be tanks in the convoy.

The 2d Bn, 271 Reg't spent 29 June in a base camp near a stream vic XT 6299. Approximately 15 days ago the whole Reg't was camped between SROC CON TRUNG (XT5785) and the Saigon River.

The captives were instructed by their commanders to move southwest after the battle. One captive stated that approximately 15-20 days ago worksite 9 (9th Division) Headquarters was along the SUOI BO Stream (KT5977). This captive also states that his father was killed by the VC and he was drafted.

(G2 Comment: The VC appeared to withdraw to the southwest as stated by the captives. All prisoners are from 271st Reg't and indications are that no other unit was involved in the battle. The VC will probably return to Zone C, and possibly to the same area the captives indicate they were 15 days ago. Interrogations continued.)
