- 1. The field house located on Hall Street between Vibbert Avenue and Wold Avenue is designated the "BRIANT WELLS FIEID HOUSE" in honor of MAJOR GENERAL BRIANT H. WELLS (Deceased), Commandant of The Infantry School from y November 1923 to 8 March 1926.
- 2. During General Wells! tour of duty as Commandant of The Infantry School, plans were conceived for Doughboy Stadium and Gowdy Field; funds were raised for these projects by means of a world-wide solicitation of infantrymen; and the construction of these two fine athletic plants was carried through to completion. The old theater and the handball courts on Ingersoll Avenue also were planned and work thereon initiated during General Wells! tour of command. His close personal and enthusiastic support of athletics at this station was continuous and effective. His influence on soldier recreation not only at Fort Benning but throughout the entire Infantry was outstanding and continuous to the day of his retirement from active service.

NAMES OF NATURAL AND MAN-MADE FEATURES OF THE FORT BENNING RESERVATION

1. POLICY

The following policy is announced with respect to names for natural and man-made features of the Fort Benning reservation. Any instructions in conflict therewith are hereby rescinded.

2. GENERAL

- a. Existing names, which have the benefit of common usage or which appear on the latest official map, will not be altered.
- b. Existing buildings, already well known by their functional use, will not be named. The advisability of naming future buildings will be decided at the time, based on current considerations.
- c. The responsibility for initiating action to name any natural or man-made feature rests with the staff agency or activity having primary interest in the feature. Representation will be made by such staff agency or activity direct to the Topographical Board. The latter will be responsible for selection of the name and its publication in orders.

3. SOURCE OF NAMES

- a. Except as noted in b, c, and d, below, all names will be selected from deceased infantrymen of all ranks and grades who were awarded the Congressional Medal of Honor or the Distinguished Service Cross in World Wars I and II.
- b. Selection of names used within the Main Post of Fort Renning will be based primarily on the prestige and importance of the individual with secondary consideration being given to combat record. While such names usually will be those of deceased infantrymen of World Wers I and II, this does not preclude consideration of deceased members of other branches of the Army who have made a major contribution to the infantry.
- c. Roads will be named with the soubriquet of infantry divisions or by the division designation in case the soubriquet is not appropriate.
- d. Woods ordinarily will not be named. If the need for a name for a particular woods should arise, it will be selected from those infantry units below divisions in World Wars I and II.

4. OFFICE OF RECORD

In order to provide continuity of records pertaining to names assigned to the natural and man-made features of the Fort Benning reservation, the Adjutant General's Office, The Infantry Center, is designated as the office of record. It is the responsibility of the Topographical Board to furnish the Adjutant General's Office, Miscellaneous Division, with complete information pertaining to all new names awarded.

5. MAP REVISIONS

It is the responsibility of the Army Field Printing Plant to coordinate with the Adjutant General, The Infantry Center, any proposed revision of existing maps in order to insure consideration of all names assigned to the natural and man-made features of the Fort Benning reservation.

SUBJECT: Research and Analysis Office

- 1. Pursuant to Academic Department Memorandum Number 22, Il April 1949, subject "Reorganization of the Academic Department" a Research and Analysis Office is activated as a staff agency in the Office of the Assistant Commandant, effective 1 May 1949.
- 2. Composition of the office will be as designated from time to time by the Assistant Commandant. It will initially consist of three (3) officers. Colonel A. D. Smith, Ol8 942, Infantry, is announced as Chief of the Office.
- 3. The mission of the office is to conduct research and prepare analytical studies on such subjects or projects as may be assigned to it by the Assistant Commandant. It will be particularly concerned with matters pertaining to the development and perfection of infantry and airborne tactics and techniques. In addition, it will be concerned with studies on projects pertaining to the operation of The Infantry School. The Office will not conduct field tests or laboratory experiments. Projects pertaining to infantry and airborne units which may be assigned to the office for study include organization, tactics and doctrine, training, armament, equipment, material and principles and techniques of ground, sea, and air movement.
- 4. In addition to the above the members of the Research and Analysis Office will conduct inspections of instruction, review examinations and small unit problems, and other similar duties as may be prescribed.


RECRGANIZATION OF THE ACADELIC DEPARTMENT
